Following the motion, Mr. Goodson expressed concerns about the advertisement and stated he does not agree with the 1.5 millage rate proposal. Mr. Johnson asked when will the ½ cent sales tax sunset? Mrs. Ellen Folsom stated December 2025, however the referendum must be on a General Election ballot. There was discussion about how much the 1.25 vis 1.5 mills generate and how much the ½ cent sales tax generates each year. Mr. Johnson stated he does not like paying taxes any more than others, but our students need it and the millage increase would cost a person who owns a \$200,000 home approximately \$40 per year. Mr. Pumphrey reminded the board this is for the advertisement. Mr. Johnson asked Mrs. Folsom when is the final vote? Mrs. Folsom stated September 17th and she stated once advertised the board can only go down on the millage, there is no going up.
