QUALIFICATIONS:

Good knowledge of department and school locations. Working knowledge of departmental rules and regulations. Elementary knowledge of office practices. Ability to follow written and oral instructions. Ability to sort and carefully handle mail and supplies, and to keep records and make reports. Skill in the operation of an automobile or truck.
