Good afternoon Steve,

Finance asked if were able to reduce implementation cost (8-9k) or waive the first year SaaS (9k).

Based on this ask, if sounds like reducing the initial year cost by 8-9k would work.

Right now, the first-year cost is \$28,698 and the 2<sup>nd</sup> year cost is \$9,818. We could take the cost for years 1 and 2 and spread that out evenly for 2 years, which would bring the initial cost down by 8-9k.

(Year 1)  $$28,698 + (Year 2) $9,818 = 38,516 \dots $38,516$  divided by 2 = \$19,258. This highlighted number is what we would invoice you for year 1 and year 2. Year 3 would go back to \$9,818.

Does this make sense & would this be doable?
